Diane will also invite the Archivist and Archives Chair to attend out meeting. Please bring back to your group the information emailed on the Budget, Archives Chair, and Archivist. Also, as requested by Diane in an email, please submit questions for the Archivist and Archives Chair in advance to be discussed at our next District meeting.

Agenda Items in print vs digital. Do we want a printed copy? A motion was made to pay for one copy of the Agenda Items to the Area. Motion passed. When it comes to the Delegate's Agenda Items meeting, District 16 will pay the expense of the Agenda Items and we will offer to split the cost to attend their meeting.
